Throughout the development of the Expanded Learning Opportunities Grant Plan (ELOGP) and the Local Control Accountability Plan (LCAP), Freshwater Elementary School District sent surveys and had many meaningful conversations with stakeholders which contributed to the development of the ESSER III expenditure plan. Engagement groups consisted of: The Freshwater School District Board of Trustees, District Certificated and Classified Staff members, local bargaining unit, administration, parents/guardians, and the Freshwater School Site Council.

Feedback was also gathered via our school website, emails, and phone conversations. This input was gathered and reviewed by district administration.

These groups provided feedback about how to best prioritize the District's actions and services for students during the COVID-19 pandemic. Furthermore, during the regularly scheduled Governing Board meeting to be held on October 12, 2021, Freshwater School District will include on the agenda the approval of the ESSER III expenditure plan and will offer the opportunity for public comment. In addition, prior to this board meeting, the ESSER III expenditure plan will be posted on the Freshwater School District website to give parents/guardians and staff the opportunity to review and provide feedback during the board meeting.

A description of how the development of the plan was influenced by community input.

Stakeholders have shared that they would like to have more opportunities for students to be provided with additional academic support and enrichment activities to make up for learning loss and social isolation as a result of our emergency school closure and subsequent distance and hybrid learning educational models. Stakeholders have also expressed the desire to increase social emotional education and support services for students. Staff and community members would like to make sure our technology is updated and devices are readily available to all students and staff. Stakeholders have been supportive of in-person learning opportunities for all students as opposed to the online distance learning format.

The feedback that was received by the various community engagement strategies listed above helped develop the ESSER III expenditure plan to include the following services: Freshwater School District will provide full time in-person instruction, intervention classes, after school homework club, social and emotional support provided by our Student Support Provider, and two years of summer school opportunities as well as restarting our Afterschool Program. These goals and services will support safe and continuous In-person learning and address the academic, social, emotional, and mental health needs of all students.

ESSER III Expenditure Plan Instructions

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before October 29, 2021 and must be submitted for review and approval within five days of adoption. A school district must submit its ESSER III Expenditure Plan to its COE for review and approval; a COE must submit its plan to the California Department of Education for review and approval. A charter school must submit its plan to its chartering authority for review and to the COE of the county in which the charter school operates for review and approval.

In addition, consistent with the requirements of the ARP, Volume 86, *Federal Register*, page 21201, April 22, 2021, the ESSER III Expenditure Plan must be:

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
 - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.
