**PAC (Formerly SSC) MEETING:** Freshwater School is creating a Parent Advisory Council (PAC) to replace our School Site Council (SSC). The PAC will meet monthly to inform our Local Control and Accountability Plan (LCAP) Monitoring and development and also oversee our Community Schools Grant. The PAC will hold its first meeting on December 7 from 6:00-7:30 p.m. in the Freshwater Conference Room and the meeting is open to the public. The majority of the PAC should be composed of parents that have a child attending Freshwater School. The PAC must include representation of parents/guardians of unduplicated students (low income, foster, and English Learners). The PAC must also include representation by parents/guardians of students with disabilities (SWD). District staff acts as liaisons between the Board and the PAC.
